This is in continuation to the directions, issued by Ministry of Power (MoP), under Section 11 of the Electricity Act, 2003 to Generating Companies, having Imported Coal Based (ICB) plants, vide MoP letter No. 23/13/2021-R&R (Pt-3) dated 20th February, 2023 (Copy enclosed), and the Clarification issued vide MoP letter No. 23/13/2021-R&R (Pt-3) dated 31st March, 2023 (Copy enclosed). The validity of the aforesaid direction was from 16.03.2023 to 15.06.2023.

- 2. Subsequently, the validity of the direction was extended upto 30.09.2023 vide MoP letter dtd 12.06.2023, which has been further extended till 31.10.2023 vide MoP letter dtd. 23.08.2023 (Copy enclosed).
- 3. In view of the surge in electricity demand, inadequate supply of domestic coal and the reduced availability of hydro generation, it is imperative that the availability of power from Imported Coal Based (ICB) generating stations is available to meet the demand. Therefore, after consultations with the Central Electricity Authority, Government have decided to extend the time period for Section 11 directive to imported coal based generators, upto 30.06.2024.
- 4. This issues with the approval of the Competent Authority.
