Sir,

Reference is invited to revised Standard Bidding Documents (comprising "Request for Proposal (RfP)" and "Transmission Service Agreement (TSA)") for procurement of Inter-State Transmission Services (ISTS) through Tariff Based Competitive Bidding (TBCB) process, issued by Ministry of Power, vide OM No. 15/1/2017- Trans dated 13th August 2021 and the amendment issued for inclusion of provisions of Aggregate Capital Cost w.r.t. HVDC Systems, vide OM No. 15/4/2021-Trans-Part (2) dated 21st June 2023. In this regard, I am directed to say that it has come to the notice of this Ministry that many private transmission developers do not fulfill the technical requirement for bidding of HVDC systems through TBCB route, as per the specified qualifying criterion w.r.t. HVDC Systems (i.e. aggregate capital cost of projects/ aggregate payments received (CAPEX) to be met by the bidding company or Lead member of the Bidding Consortium) incorporated in the Standard Request for Proposal (RfP).

2. The matter has been examined in this Ministry, in consultation with CEA, and it has been decided to modify the para 2.1.2 of the Standard Request for Proposal (RfP) document as given below for increment in Experience of development of projects in the Infrastructure Sector and number of projects:
